 3. GPA of 2.5 in 9 SCH of lower division English; 6 SCH must be in composition
 4. GPA of 2.5 in courses that apply to degree and/or specialization
 5. GPA of 2.5 in lower division courses that apply to teacher certification
 6. Proof of a clear criminal history check – student must submit results to their Certification Analyst **before** admission to Teacher Education
 7. Evidence of the characteristics, behaviors, and attitudes appropriate to the teaching profession.
 8. Lower division courses must be completed before admission to Teacher Education
